Were you aware that Hotchin and all of those guys were out to get you?



Dear Minister

I write on behalf of the Media Freedom Committee in support of the National Business Review newspaper and its request to the government to consider changes to the Serious Fraud Office Act.

At its regular meeting this week, the committee considered issues surrounding the SFO's demand last month that the NBR provide it with documents under a 'production order' -- the first time, to our knowledge, that such a provision has been used against a media organisation.

We have seen the letter to you from Nevil Gibson, editor-in-chief of the National Business Review on October 22, and have had the benefit of your reply, dated November 2 and a briefing from Nevil Gibson on your subsequent meeting on November 17.

Media Freedom Committee members are unanimous in deploring the SFO's misuse of its powers to demand information from the NBR newsroom. These powers could not have been intended by Parliament to be used against legitimate news gathering, and certainly not in a manner in which confidentiality of sources could be threatened.

Far from being a reassurance, the fact that this is the first time such an order has been used against the media is of profound concern. A new director and new approach to SFO investigations ought not to cut corners and imperil legitimate media freedoms. There is a real danger that those who act as confidential sources for stories of great public importance -- very often highly sensitive matters involving the powerful and those in authority -- will no longer feel secure to bring matters to public attention via the media if these unchecked powers remain.

The Media Freedom Committee urges you as the Minister in charge of the SFO to change its Act, specifically to exclude news media from examination and production orders. In the meantime, we support the NBR's call for the SFO to be instructed not to invoke its powers against news organisations until the Act can be amended.
